THE 3 ROLES OF THE COURT OF JUSTICE

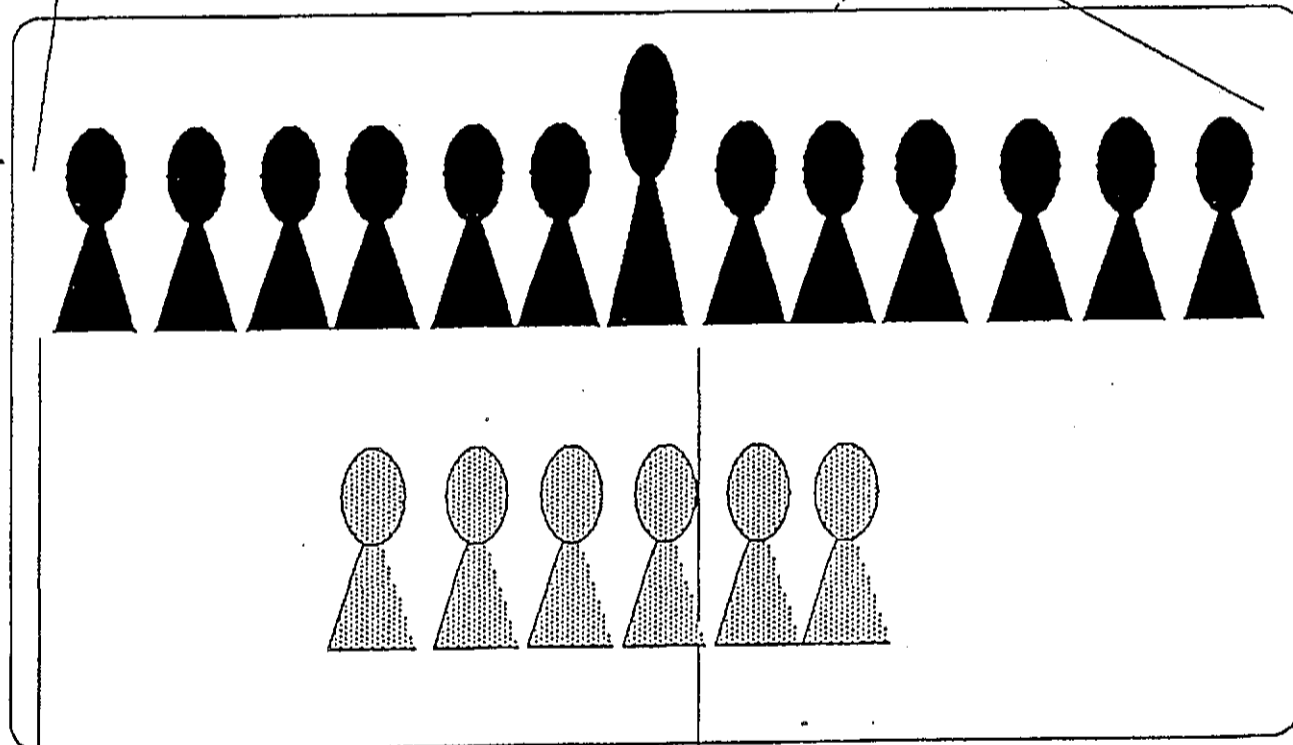

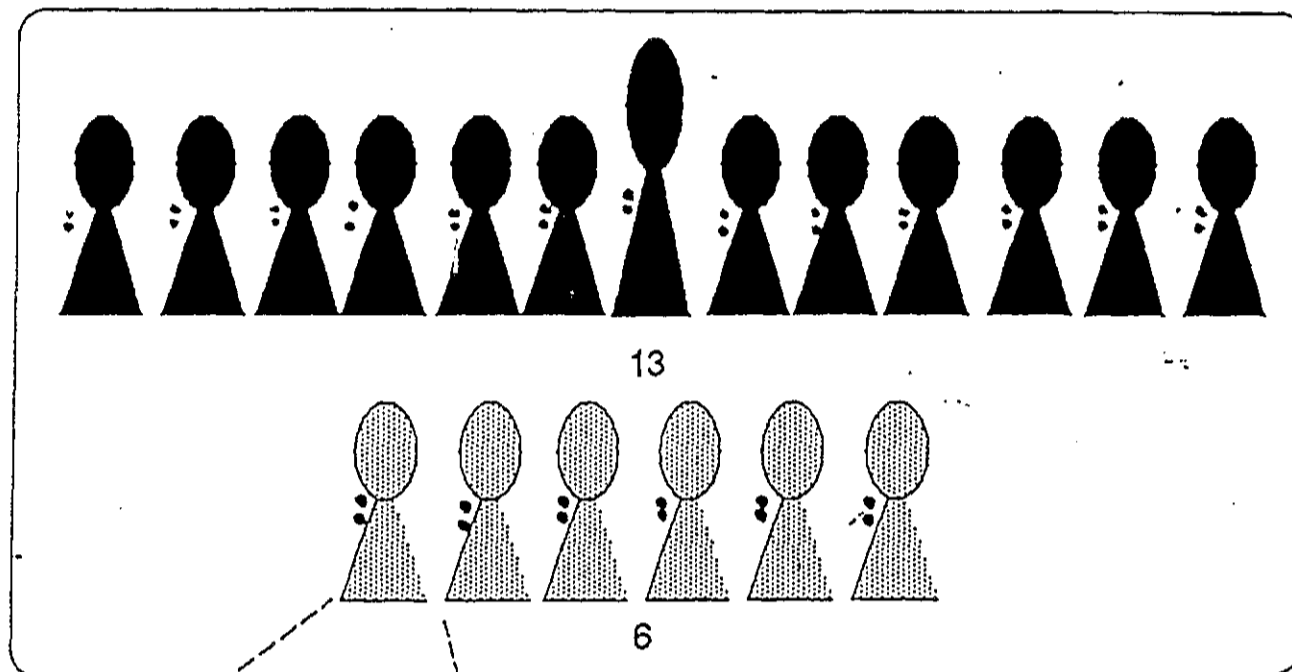

– assigns cases to individual advocates – general as soon as the judge – rapporteur has been appointed by the President.

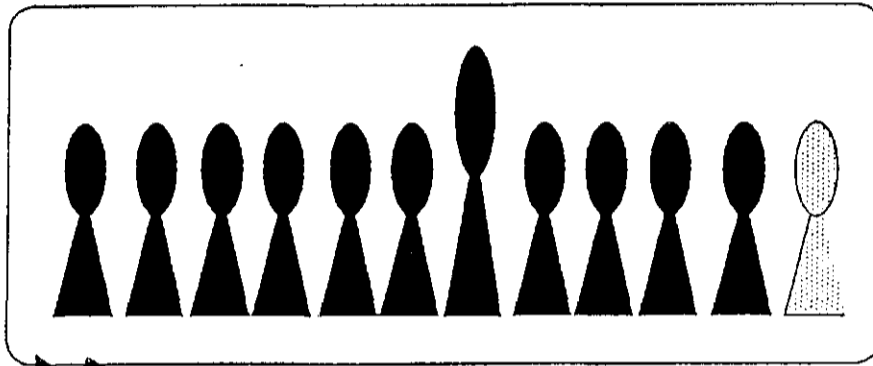
